IN RECOGNITION OF FSBPA'S 2014 AWARD WINNERS



Steve Boutelle, Stan Tait Award

The Association's highest award is the Stan Tait Award for "truly outstanding contributions" to Florida's beaches over a number of years. It is a rare occurrence for an individual to be nominated by two different people for the same award. However, this is the case for Steve Boutelle, Operations Manager for Lee County Natural Resources, nominated by both Tamara Pigott, Lee County Visitor and Convention Bureau and Virginia Barker, Brevard County. In reviewing Steve's track record of service to both Lee County and FSBPA, it is easy to see why.





For the last 25 years, Steve has been dedicated to the preservation of Florida's beaches and coastal resources. Steve has provided oversight for multiple nourishment projects on Gasparilla Island, Estero Island, Lovers Key and Bonita Beach, approaching each project with sound science and great diplomacy. He has served on the Board of FSBPA in one capacity or another almost continuously since 2004 and is the Association's current Chair. Additionally, he served as Chair of the State of Florida Beach Management Working Group in 2008-2009 and served on the Adaptation Technical Working Group of the Governor's Action Team on Energy and Climate Change in 2008. He is also the Southwest Region Member



of the Florida Marine Mammal Stranding Network and serves on the Manatee Regulatory Working Group, USFWS Manatee Recovery Team. Steve's commitment to the statewide beach program and the preservation of Lee County beaches demonstrates that he is most worthy of this exceptional award.

Dr. James Houston, Bob Dean Coastal Research Award



Dr. James Houston is the honored 2014 recipient of the Bob Dean Coastal Research Award, named after the University of Florida's Professor Emeritus and FSBPA's Chair Emeritus. This award is presented to an individual for outstanding research into beach and coastal processes. Dr. Houston retired from the USACE following a career of over 38 years, leaving behind a legacy of unprecedented accomplishments, having managed a most diverse research organization – several laboratories located in four states, with more than 2,000 employees, \$1.2 billion in facilities, and an annual program exceeding \$1.5 billion. He advised the Commanding General of the Corps on matters of science and technology and developed research and development policy for the Corps.

Dr. Houston was nominated for this award by Jackie Keiser, USACE, a former colleague and also a former Stan Tait Award recipient. Dr. Dean himself supported the nomination, saying that "He has elevated the economic value of beaches to the Nation and local governments through his meticulous documentation of the publications of professional economists and detailed examination and dissemination of the benefits of beach nourishment." Dr. Houston was elected to the FSBPA Board for his first concurrent term at the 2012 Annual Conference. He consistently responds to the needs of FSBPA through presentations, research, publications, and generously provides the Association wise counsel and guidance.

Charlie Hunsicker, Local Government Award

FSBPA is pleased to recognize Charlie Hunsicker,
Natural Resources Director, Manatee County, for the
Local Government Award. Over his 30 years as
Director of Manatee County's Parks and Natural
Resources Department, Charlie has exemplified the type
of leader that Florida's coastal governments need – he is
passionate and driven in every aspect of his daily life to
fight to protect, restore and enhance Manatee County's
beaches. He has served on the FSBPA Board since





2008 and is currently serving on the Executive Committee as Past-Chair. His tireless efforts and seemingly boundless energy have provided Manatee County with an unsurpassed level of service. Combining federal and local-sponsored beach projects has not only saved millions of dollars, but it has also minimized impacts to the coastal environment and to Anna Maria Island's valuable tourism industry. Charlie understands that working with the municipalities on Anna Maria Island leading up to and throughout the construction of projects is crucial for awareness and addressing the concerns of the community.

Keith Laakkonen, Environmental Award



This year's Environmental Award recipient is Keith Laakkonen, Environmental Sciences Coordinator for the Town of Fort Myers Beach, where Keith has made numerous contributions to beach preservation and enhancement. Keith led the development of a partnership program for the management and conservation of beach nesting birds with the Town of Fort Myers Beach, Audubon of Florida, DEP, FWC, and several private property owners. Keith also developed an innovative beach vegetation management plan with DEP, which is

the first of its kind in Florida. This plan allowed private property owners who signed easements for the Estero Island Beach Restoration Project to manage dune vegetation on their property under specifications which increase the functionality of the overall dune system on Fort Myers Beach. This has resulted in over half a mile of new dune establishment.

Representative George Moraitis, 2014 Legislator of the Year Award

We will honor Representative George Moraitis, District 93, Florida House of Representatives, as the recipient of FSBPA's 2014 Legislator of the Year Award. This award goes to a deserving and committed state or national lawmaker for significant contributions and outstanding leadership in support of the management of Florida's beaches. George was born and raised in Fort Lauderdale and is a graduate of Fort Lauderdale High, the United States Naval Academy, and the University of Florida's College of Law. A real estate attorney by trade, George was first elected as a State Representative in November 2010. Since that time, he has been a tireless advocate for the beaches of Broward County and for the statewide beach program, working hard to learn the issues associated with beach





management, pressing for increased funding for the statewide program, and urging consideration of the economic benefit of projects and storm damage response in the appropriations process. He is a persistent and effective advocate and FSBPA is pleased to have the opportunity to work with legislators such as Representative Moraitis who show this kind of passion for Florida's beaches.

Bonita Beach and Lovers Key Nourishment 2014

Lee County successfully constructed initial beach restoration projects on both Bonita Beach and, in partnership with the Florida Park Service, on Lovers Key State Park in the 1990s. The first maintenance renourishment of Bonita Beach took place in 2004; shortly after, maintenance fill was also placed along critically eroded shoreline sections on Lovers Key. In 2012, Coastal Tech was selected by Lee County to provide the full range of professional services necessary to construct the second maintenance of both Project segments. The County desired to

maintain both

Project fill

segments generally as previously designed and constructed. However, work began with a full review of previous FDEP-required monitoring and Project performance, and included recommendations for design enhancement. Because the two Project segments have different owners/sponsors, they also have different cost sharing formulations, and part of the Project Management service was to separate and track fees for each area to the extent practicable.



Sand for the 2004 maintenance was excavated by a hydraulic cutterhead dredge from the Big Carlos Pass ebb shoal. Because this shoal was a near-by compatible and economical source for the beach fill, the new sand search focused on using additional portions of the ebb shoal deposit for the current Project. Through sub-consultants American Vibracore Services and FAS, Coastal Tech completed a full field investigation including obtaining seismic data, vibracores and performing a cultural resources assessment. Data and core samples were reviewed and analyzed, and proposed borrow area limits and cuts were designed.

A major FDEP concern during permit application review was the potential effect additional ebb shoal dredging might have on sections of adjacent shorelines. Coastal Tech performed a multi-track evaluation to address that issue using a combination of numerical modeling and past monitoring results. In 2013 Coastal Tech completed the Project Area fill design, obtained FDEP and USACE permits for the Project and prepared Construction Documents for subsequent bidding by the County. The total timeline for all permitting was less



than 17 months. Although FDEP did *not* expedite project review using proposed Rule FAC 62B-49, it was one of the first nourishment permits issued for 15 years or two nourishment events.

Because of contract limitations, Lee County issued a new solicitation for Construction Phase Services which was awarded to Coastal Engineering Consultants (CEC). CEC brings to the effort many years of successful construction phase work and a history of monitoring and other surveys in Lee County. The proximity of CEC staff to the projects and an intentioned flexible approach allows CEC to work in parallel with County staff and 'round out' resident engineer presence. CEC sought out and engaged Coastal Tech's Engineer of Record as a sub-consultant to assist during construction with interpretation of technical specifications and provide continuity for final regulatory certifications.



The 2014 Project includes placement of approximately 133,000 cubic yards (cy) and 328,000 cy on Bonita Beach and Lovers Key, respectively. The Engineer's Opinion of Probable Construction Cost was \$4.7 million. Lee County bid out the Project in spring 2014 and received four bids. The bids ranged from \$4.7 million to \$9.0 million with an average of \$6.4 million. Orion Marine Construction of

Tampa Florida was the successful bidder. Orion began mobilizing to the

Project area in June and are currently underway with the Bonita Beach segment. They are using their 16" hydraulic cutter suction dredge, Jeri B, along with two boosters and attendant plant and equipment. Up to 22,000 linear feet of pipe will be utilized to construct the Project utilizing the two designated borrow areas within the Big Carlos Pass ebb shoal complex. The material



placed to date is consistent with the borrow area characterization and has been well received by residents and agencies. Based on current production rates substantial completion of both segments is expected by this November.

Civil Works Review Board Approval for Flagler County – August 2014

The Civil Works Review Board (CWRB) meeting for the Flagler County, Florida, Hurricane and Storm Damage Reduction (HSDR) Project, Final Integrated Feasibility Study and Environmental Assessment was held on August 26, 2014 in Washington D.C. The Jacksonville District team



along with representatives of Flagler County, the Florida Department of Transportation, and the City of Flagler Beach provided a presentation of the recommended plan that will significantly reduce damages to State Road A1A in Flagler Beach for 50 years. The Chair for the CWRB was Major General (MG) Peabody, Deputy Commanding General for Civil and Emergency Operations. The Board Members for the CWRB were Mr. Theodore (Tab) Brown, Planning and Policy Division Chief; Mr. Steve Stockton, Director of Civil Works; Mr. James Hannon, Operations and Regulatory Community of Practice Chief; and Mr. Joseph Calcara, Director of Programs, South Pacific Division. The Board unanimously agreed to approve the release of the final integrated report and the draft Report of the Chief of Engineers for state and agency review.

The CWRB was established by Engineering Circular (EC) 1105-2-406 dated March 31, 2005, and is applicable to all Corps of Engineers Civil Works feasibility reports and post authorization reports where new Congressional authorization is necessary. The Flagler County Project was the first Jacksonville District HSDR project to complete a CWRB. The CWRB serves as the corporate checkpoint to determine that the final report and NEPA document are ready for state and agency review. The state and agency review for the Flagler Report is scheduled to be completed in October 2014. The final approval of the report will occur with the signing of the Chief of Engineers Report which is scheduled for November 2014.



The recommended plan for Flagler County consists of a ten foot dune and beach profile extension along 2.6 miles of shoreline in Flagler Beach and mainly prevents damage to most vulnerable sections of State Road A1A, an important hurricane evacuation route. Initial construction will require approximately 330,000 cubic yards of sand, and each periodic nourishment event will require approximately 320,000 cubic yards. The renourishment interval is expected to be approximately 11 years, **Next Page**




equaling 4 renourishment events in addition to initial construction over the 50 year period of Federal participation. The borrow area is located 7 miles offshore of the placement area within Federal waters.

The benefit to cost ratio (BCR) for this project is 1.9 to 1. Initial construction will be cost shared at 65% Federal and 35% non-federal. Periodic nourishments will be cost shared at 50% Federal and 50% non-federal. The Federal share of the total project cost over 50 years is \$24,608,300 and the non-federal share is \$20,353,700 in FY15 price levels.


The recommended plan additionally provides social and environmental benefits by protecting a critical evacuation route, maintaining opportunities for tourism and recreation, and establishing nesting habitat. The non-federal sponsor, Flagler County, is in full support of the recommended plan.

FDEP Division of Water Resource Management Agency Updates

New Beach Nourishment Geographic Information System Layers Created

Department GIS staff have created a more user friendly GIS layer of beach nourishment projects. These layers were created to update and replace existing GIS layers to help address a couple of problems. The first problem was the overcrowding of permit lines being displayed. The old layer captured all of the permit applications received by the Department, regardless of their status. Inclusion of permits that were never issued led to the layer containing too many unnecessary lines. In the new layer, only permits that were issued by the Department were included. This includes both active and expired permits and modifications. Also, a link to the DEP Information Portal was added as an attribute in the layers table to allow users to view documents associated with each permit.

The second problem was coast line conformity. The old layer displayed lines that connected the beginning and ending range monuments for the permits in a straight line, regardless of the coastline (which often resulted in a line through the ocean or land). Using 2011-2013 aerial imagery, the new layers were digitized to conform to the coast.

The purpose of this task is to provide staff and the public with more accurate GIS nourishment layers that will allow the user to better locate and view approved nourishment permits throughout the state of Florida. The layers will be made available in SDE, DataMiner, Map Direct and on the DEP ftp site.

Funding requests for beach and inlet projects were due August 4, 2014. Sixty-one projects, requesting \$102 million in state assistance were received and determined to be eligible. All requests had been reviewed, and requests for additional information, or clarifications, have been posted by County and name at http://www.dep.state.fl.us/beaches/programs/becp/fund-req.htm. Responses are due by September 1, 2014, except that resolutions from governing boards may be submitted through September 30, 2014.

Rules Update

The Division held a workshop on draft Rule 62B-33, Rules and Procedures for Coastal Construction and Excavation (CCC permitting) on June 23, 2014. Numerous comments were received by the August 15, 2014 deadline. Staff is reviewing them to determine what changes to recommend.

The Department hopes to publish a notice of change to the draft modifications to Rule 62B-49, Joint Coastal Permits and Concurrent Processing of Proprietary Authorizations soon. The majority of comments received from the Joint Administrative Procedures Committee have been resolved.
