Unveiling of the 2021 Annual Conference Award Recipients

Stan Tait and Deborah Flack Award

Virginia Barker, Director of the Brevard County Natural Resources Management Department, was nominated by Debbie Flack and Mike McGarry to receive the association's highest award for truly outstanding contributions in the preservation of Florida's beaches over many years.

Anyone who is privileged to know Virginia recognizes extraordinary work ethic and her tenacity and readiness to meet every challenge. Virginia began her career in Brevard County 20+ years ago as the beach program manager. Today she continues to oversee the county's 36 miles of beaches and manages a myriad of other environmental programs, most notably the Save our Indian River Lagoon Program. instrumental in guiding the association through transitions and supporting FSBPA's legislative agenda and the statewide beach management program. The Richard E. Bonner – Jacqueline J. Keiser Award

His most notable role may be his accomplishments serving as the Regional planning lead for SACS – a massive study covering 65,000 square miles, five states and two territories.

Matthew's experience, ingenuity and visionary leadership have contributed extensively to Florida's successful coastal program and the U.S. Army Corps of Engineers. Matthew was nominated by Ms. Jacqueline Keiser and is the first recipient of the award since it was renamed after Richard and Jackie. Congratulations, Matt, on this well-deserved accolade. Minimal Impacts from Tropical Storm Fred

RCP conducted inspections from Mexico Beach to eastern Walton County and received reports from the Florida Park Service after Tropical Storm Fred made landfall Aug. 16, 2021, in eastern Gulf County with wind gusts up to 70 mph and a storm surge of 3.5 to 4 feet.

Minimal erosion was observed other than at known isolated high erosion areas. There was significant flooding but no structural damage. A Federal Emergency Management Agency berm construction project on St. Joe Peninsula was interrupted.

Thank you to all the local sponsors and park service staff who assisted in documenting this event.

St. Joseph Peninsula - Gulf County

R103 – Condition II. This area sustained dune erosion during last year's tropical storms and Hurricane Sally. The dune erosion from Fred threatened turtle nests.





R102-R101.5 – Condition III. And R101.5-R101 – Condition II. Moderate beach and dune erosion was sustained immediately north of the Sunrise-Sunset Condominiums tapering into minor beach and dune erosion.

Beach Management Funding Requests

The Beach Management Funding Program received 45 applications for beach and inlet management projects for Fiscal Year 2022-23. The Local Government Funding Requests, which were due July 31, included 37 beach projects (13 monitoring only) and eight inlet projects (one monitoring only) for a total state share of \$67.8 million.

The department is evaluating and ranking projects consistent with Chapter 161, Florida Statutes (F.S.); procedures outlined in Rule 62B-36, Florida Administrative Code (F.A.C.); and readiness to proceed with the proposed funding request. Draft project assessments will be released Aug. 31 via email and posted on the Beach Funding Program website. Local sponsor comments are due by Sept. 21.

If funding requests for projects were not submitted this year, please submit the project timeline and budget for the next five years to be incorporated into the department's statutory-required three-year work plan and long-range budget plan.

New Method to Access Permit Information

Many individuals have become accustomed to using the Beaches, Inlets and Ports Program's permits-by-county webpage to quickly and easily access permitting information for specific projects.

Because many browsers are not supporting FTP, the department is moving away from supporting FTP, and the permits-by-county page will no longer be functional. All files previously on the site are now on Oculus. Department staff have also been working on a geo-referenced map to replace the permits-by-county page that will allow individuals to zoom or scroll to a geographic location then click on a "symbology" at a project location, which will lead to all the relevant files of that project.

It is our goal to have this platform publicly accessible in the fall of this year. Annual Inlet Report Now Available

The Annual Inlet Report has been finalized and is in final review before being posted on the department's website, as required by Section 161.143 (5), F.S. The purpose of the report is to show how each inlet project has succeeded in balancing the sediment budget of an inlet and mitigating the inlet's erosive effects on adjacent beaches.

The report indicates the percentage of the bypass objective met for each managed inlet along Florida's Atlantic and Gulf coasts. The report also lists and illustrates each inlet's annual bypass volume, annual objective, cumulative volume and cumulative objective. The purpose and intent of Section 161.142, F.S., inlet management strategies are to mitigate the contemporary inlet effects, not the historical effects, of an inlet. Sea Level Impact Projection (SLIP) Rule and Tool:

Sea level rise and coastal flooding are affecting an increasing number of Florida's coastal communities. The SLIP study rule, as authorized by Section 161.551, F.S., is an unprecedented step toward considering the impacts of sea level rise on coastal construction in Florida. Chapter 62S-7, F.A.C., became effective July 1, 2021, with enforcement beginning July 1 2022.

The rule applies to new coastal structures (major or non-habitable) being built by state-financed constructors in the coastal building zone. If the constructor meets the criteria to conduct a SLIP study on or after July 1, 2022, a SLIP study must be completed. Users can choose to use DEP's web-based SLIP tool, which is user-friendly, fast and free, or they can conduct their own SLIP study following the standards outlined in the rule.

Construction cannot commence until the SLIP study has been completed, submitted to the department and published on DEP's website for 30 days. All SLIP studies will remain on DEP's website for at least 10 years. Find more information about the <u>SLIP rule and tool</u>.

Resilient Florida Program

RCP is in the hiring process for the new program, with many job opportunities available. Visit MyFlorida.com and search by "resiliency" and "Tallahassee."

Rule development for the program has begun, and a workshop will be scheduled soon. Applications will be reviewed after the grant portal closes Sept. 1, 2021. A ranked project list will be submitted for legislative consideration.
